With the object of establishment of a college at Raniganj
Grihiti Tribeni Devi Bhalotia, wife of Shri Sanwarilal Bhalotia of
Raniganj has given a donation of Rupees One lakh on the following
conditions:-

- (1) That the college will be named as "Triveni Devi College".
- (2) That one nominee of the Donor will always be taken in the Governing Body of the College.
- (3) That the Donor shall be entitled to recommend for admission four students possessing requisite qualifications in the 1st Year and four students possessing requisite qualifications in the 3rd Year classes in every session.

The local promoters at Raniganj are also prepared to make a gift of 25 to 30 bighas of land for the aforesaid purpose. In consideration of the above donations and there being a necessity for a college at Raniganj, it has been decided that a Government-Sponsored College should be set up there under the Development Scheme.

In pursuance of the above decision, Government are pleased to accord their approval to the establishment of a Government Sponsored College at Raniganj with effect from the ensuing academic session on a grant-in-aid basis subject to the following terms and conditions:-

- (1) The land measuring 25-30 bighas free from all encumbrances proposed to be donated should be made available to the college immediately.
- (2) The college should be named as "Triveni Devi College, Raniganj."

- (5) The rates of fees for students should be fixed at Rs. 8/- per month each in I. ... classes at Rs. 10/- per month each in B.A. (Pass) classes.
A Development fee of Rs. 1/- per month per student should be released from the students.
- (6) The college should appoint and maintain an adequate staff as detailed in the annexed statement with requisite qualifications and scales of pay. The recruitment of staff should be made on the basis of actual requirements of the college.
- (7) The college should have a properly constituted Governing Body subject to the proviso that one nominee of the donor will always be taken in the Governing Body.
- (8) The Donor shall be entitled to recommend for admission, four students possessing requisite qualifications in the 1st Year and four students possessing requisite qualifications in the 3rd year classes every session.
- (9) The actual deficit of the college will be met by Government.
- (10) The college will be run in accordance with the terms and conditions of a Sponsored College as approved in terms of Govt. Order No. 11173-Edn., dated the 31st October, 1956.

Pending construction of buildings for the college, it should start functioning in the Rangraj High School in the morning on payment of a reasonable rent to be sanctioned by Govt. in due course.

Administrative approval of Government is hereby accorded to the scheme at an estimated capital expenditure of Rs. 3,35,000/- towards the construction of buildings, purchase of furniture, equipments and books to be financed as follows:-

(including sponsored) colleges.

It was stipulated in Government Order No.1080-Edn(CS) dated the 28th October, 1970 by which the integrated scale of pay was introduced, that financial assistance on the terms contained in that Government Order and subsequent Govt. Orders on the subject, would be admissible to the colleges only in respect of posts which had already been approved by the Government pending the fixation of the norm of work-load for college teachers. The Governor was pleased to declare in G.O.No.1080-Edn(CS) dated the 28th October, 1970 that posts created in affiliated including sponsored colleges on or after the 1st April, 1966 and existing on the 1st September, 1970 should be treated as approved without scrutiny for facilitation the reason of financial assistance to the colleges concerned.

The Governor is now pleased to direct that posts created in affiliated and sponsored colleges prior to 1st April, 1966, which are awaiting the approval of the Government should also be deemed to be approved without scrutiny.

The Government, however, reserves its right to scrutinise the admissibility of posts that may have to be created in affiliated including sponsored colleges in future. No additional posts in any such college should be created without the prior approval, of the Government. This order is issued with the concurrence of the Finance Department vide their U.O.No,BVI/4022 dated the 16th Nov. 1970.


